7. BIRT the Budget Process below is approved (Negatu/Mandia)

a. Be it resolved that Council hear a first reading of the proposed Summer 2017 Budget

Albert: Please speak up, especially those on Skype!

Raye: I don't talk as fast as Snow, but I'll try my best!

MOTION CARRIES.

Raye does a preliminary reading of the budget created by the Executives.

- b. Be it resolved that council hear a second reading of the proposed budget, with amendments pending.
 - i. Be it resolved that council propose any increases to the budget
 - a. Dan proposes increase on Line 1101: from \$210 to \$300, increase of \$90.

<u>Dan:</u> This is likely cheaper than \$90 but I don't know exact price but I'm being safe. These are calendars posted around UC. The calendar for November is paid for in October.

Michelle: Could this possibly be from Vice President's budget?

Victoria: Are these all around residence?

Dan: Yes.

Michelle: Should this money still be considered?

Item is withdrawn. It is redundant in the Vice President's printing budget.

b. Mira proposes increase on new Line 505 from \$0 to \$370.

<u>Mira:</u> I realized I didn't budget for Rocky Horror. I'm collaborating with New College and Tua. This is for food and drinks for the event.

<u>Dan:</u> I noticed social budget – food is budgeted for Halloween event. Do you need to budget this extra food?

<u>Mira:</u> Yes, this is extra food that you need especially with alcohol being served. We didn't expect to have as many people as we did last year, so it's largely food but also a contingency budget as well.

MOTION CARRIES.

c. Michelle Zhong proposes increase on Line 1401 from \$300 to \$350.

<u>Michelle:</u> Commission Meetings and two events I mentioned. That just adds up to \$350.

d. Kaitlyn proposes increase on Line 1205 from \$0 to \$250.

<u>Kaitlyn:</u> The Mic is dead, it's gone, it's over. Every single commission and UCRC uses the sound locker, so it's important to have all our stuff up and running for the year.

Mira: Did you research the price?

<u>Kaitlyn:</u> Ryan was very sweet and searched up the price for me before we changed over positions. It'll be around \$226.

e. Mahzeb proposes increase on Line 1003 from \$105 to \$205.

Mahzeb: So we're doing \$20 per person as thank you gifts for the 5 speakers.

ii. Be it resolved that council propose any decreases to the budget

a. Dan proposes decrease on balance on Line 1102 from \$3150 to \$1000 (by \$2150: \$1650 decrease in expense, \$500 increase in revenue)

<u>Dan:</u> Allotted \$2000 initially and it's not going to work out, nobody's going to pay that much for boxers/socks. I calculated revenue wrong only up to UCADAN so that was my calculation error.

Mira: Albert what is your orientation giveaway?

Albert: The clipboards.

b. Mira proposes decrease on Line 112 from \$1000 to \$700.

MOTION CARRIES.

c. Albert proposes decrease on Line 113 from \$500 to \$0.

<u>Albert:</u> Do reps have ideas for summer?

<u>Paul:</u> I'd be more comfortable if there was a small \$100 or \$150 for reps who have a good idea.

<u>Sameer:</u> We could also as reps use the student's initiative fund. So I don't mind the full decrease but it could be good to keep it.

<u>Mahzeb:</u> I think the students initiative fund should be used by other UC students, and we as reps should have our own fund.

Friendly amendment of decrease on Line 113 from \$500 to \$150

MOTION CARRIES.

d. Dan proposes decrease on Line 1005 from \$200 to \$0.

Mira: Could we cut it down to \$50?

<u>Victoria:</u> The commission meeting line has money for food, why do you need this food contingency?

Mahzeb: Contingency is for UCADAN in case we need more food.

<u>Mira:</u> I think that \$100 is too much for food contingency. I'm not the commissioner and not trying to overstep but I think it could still be reduced.

<u>Kaitlyn:</u> If the food contingency is used for UCADAN, trivia night is being moved up for the day, just a little later than the UCOC pancakes, so the amount of food budgeted may not be necessary. They'll be getting pancakes and lots of food already.

<u>Sara:</u> What Kaitlyn said. We're going to have a lot of food going, so this contingency may not be necessary.

<u>Meng:</u> Contingency is risk management strategy. For something like UCADAN, you have no obligation to provide food to students, once it runs out it runs out. There's no need for this contingency, this money could be used for a separate idea or initiative.

<u>Danielle:</u> My budget is just food and prizes so I'm flexible. The point of contingency is a backup, but I was very open to decrease it if possible. If council wants to decrease it to \$50, I'm fine with that. I'm fine with \$98 for 1001 and \$50 for 1005. It's very friendly. All is good guys I love you.

<u>Sameer:</u> It's fine if they have the \$50. I think commission meetings shouldn't be decreased.

Dan: I accept this friendly amendment.

Friendly amendment by Mahzeb to decrease Line 1005 from \$200 to \$50

MOTION CARRIES.

e. Martha proposes decrease on Line 701 from \$5107 to \$4881.

<u>Martha:</u> The price is lower than I expected. I thought it was going to be \$1450 but he wanted to only increase it by 50 cents last year because we always work with them.

MOTION CARRIES.

Ryan: No one can hear you Danielle. That came out meaner than I thought.

<u>Raye:</u> For orientation, can you explain why your revenue went up by \$2000? And why you're requesting \$14000?

Michelle: We have almost \$0 in our account because of last year's orientation deficit. We have a lot of inflation costs. Last year orientation didn't have a contingency on the entire budget. There are scheduling things that haven't been figured out yet because UTSU is still changing things around. We're not sure what exactly we're putting into where; we just have a general gist of what's going on.

<u>Raye:</u> Do you know how many events you're unsure about?

Michelle: At least two or three.

f. Dan proposes a decrease on Line 402 balance from \$920 to \$540.

<u>Dan:</u> Friendly to any amendment of Ben's since it's his event. Cutting 40 tickets to 30 tickets. And I'm suggesting we're increasing revenue from \$15 to \$20 tickets.

MOTION CARRIES.

g. Kaitlyn proposes a decrease on Line 602 from \$1450 to \$1250

<u>Kaitlyn</u>: Tua already budgeted for it.

MOTION CARRIES.

h. Sara proposes a decrease on Line 909 from \$200 to \$0 (Moved to Capital)

MOTION CARRIES.

Mira: Did Danielle look for a cheaper pizza place? Pizzaiolo is expensive.

Danielle: I did look at Pizza Nova, which is \$13 & tax instead of the \$17 per pizza.

i. Danielle proposes a decrease on Line 1002 from \$353 to \$322 & Line 1004 from \$120 to \$104.

j. Mira proposes a decrease on Line 803 from \$100 to \$50 & decrease on Line 804 from \$100 to \$70.

Dan: The commission meetings never cost more than \$20.

Ben: These are intramural fees we have to pay for.

MOTION CARRIES.

d. Ben proposes a decrease on Line 403 from \$100 to \$60.

<u>Sameer</u>: I think we should keep the commission meeting funding. In regards to the student's initiative fund, I'd say we could cut it down more.

<u>Mahzeb</u>: I'm fine with decreasing the student's initiative fund a little bit but not more.

<u>Paul:</u> If you do cut it please don't cut it down too much. Also both Sara and I have to go but if you have any questions about the UCOC budget please let us know.

<u>Victoria:</u> If commissioners want to decrease their budget I think it's fair to cut it, I don't see why we aren't letting them and proposing we waste more time.

e. Raye proposes a decrease on Line 1301 from \$14000 to \$13000.

<u>Sameer:</u> If orientation co chairs think it's fine I think we could go that way.

Michelle: It's aight.

Finance:

The Finance Commission isn't doing anything this summer except a couple of meetings; ~2 with the entire commission and ~2 with just me and my deputies.

Athletics:

Hello everybody! Athletics has a lot going on between now and October; I'll break down the main funding requests that I've made to hopefully give a better sense of exactly what's happening.

We'd like to hold a commission meeting in September and October to engage with the community, get the word out on events and intramurals, and hear what UC wants from the commission. As such, we've budgeted expenses for snacks and drinks at these meetings.

Similarly, we'd also like to organize a captain's meeting in September to help our captain's get started in the semester, and we've budgeted for food at this meeting as well.

There are also a variety of expenses associated with registering teams for the intramural program in summer, winter, and fall. I won't go into the specific details here, but there are several deposits that must be set down to register our teams, as well as certain non-refundable fees for specific sports. Finally, there's also fees associated with registering teams for tournaments throughout the year. We've accounted for all of these fees in our requests.

We also requested some funds to purchase additional basketball jerseys (there were not enough for our teams last year) as well as replacement jerseys, as we anticipate that not all jerseys were

returned by players last year. We also noted that some additional equipment would be beneficial

to our intramural teams, and so have requested funds to purchase this equipment.

Finally, Athletics is hoping to organize a trip to a Blue Jays game in September! We think it'd be

a great way to open the school year and will definitely be a fun time. We're considering

purchasing 40 tickets, and we're estimating the price based on available figures. We intend to

sell tickets at a marginal cost of \$15 to students, and we've noted this in our budget request.

I hope this helps clarify what we hope to do over the summer and in the opening months of fall!

I know this was super down to the wire but here is my report as requested:



Thus far, we have begun to plan for next year and have already taken action. We are currently in the process of ordering a new cash drawer to replace our broken one, as well as searching for a small shelving unit to store mugs, which goes along with one of our ideas for the next year.

On the operations side, one of our focuses for the next year will be to establish solid communication platforms between our staff and co-managers and more defined roles. One of the ways we'll be doing this is by using applications that allow for easy messaging, scheduling, and file transfers and by specializing employee roles (e.g., having an employee responsible for social media, another responsible for aesthetics and marketing, etc.).

During hiring (which will occur Late July and throughout August), priority will be given to those with great interpersonal and customer service skills. Technical skills can be quickly learned, but Diabolos' is nothing without excellent service and customer engagement.

On the finance side, we are going to do a thorough inventory analysis of prior year's sales and cost of goods sold. A more thorough analysis of profitable hours of operations will be identified. We're also just waiting on our chequebook to arrive in the mail in order to pay out some remaining invoices from last year. We are having discussions on whether we could make the barista role a work study position which could benefit both parties, such that it integrates the position more with the University of Toronto, reduces our payroll costs, and could potentially add more credibility to the barista role. Finally, we are also working on improving some of our equipment as mentioned above, as well as replacing the cash register which has lost a lot of functionality, and troubleshooting some of Diabolos' technology.
